

## **One Tenant Leaves While Others on the Lease Stay**

#### Question:

What is the procedure when one master tenant (one who is on the lease) wants to leave the lease but other master tenants are planning on staying? (*Please note that none of this applies to subtenants since Unif Management, Inc. has no formal arrangement with them.*)

### Answer:

We need you to fill out two forms for us before you depart:

- 1. *30 Day Notice*: This formally tells us you will be departing, when and where you're going, in case we need to contact you later.
- 2. Security Deposit Release Form: This releases you from being part of the disposition of the original security deposit whenever it is finally returned. The tenancy ends when comes when all keys have been returned and tenants have surrendered the unit to the Owner/Agent free and empty of all persons claiming any right to possess the premises.

- c. Remaining tenants' possession of the unit remains in effect until all keys have been returned and tenants have surrendered the unit to the Owner/Agent free and empty of all persons claiming any right to possess the premises.
